1. Ministry of Health and Population, National Tuberculosis Control Centre, Thimi, Bhaktapur invites electronic bids from eligible bidders for the item mentioned in table below for the procurement of goods to be delivered at NTCC, Thimi, Bhaktapur.

2. A bidder may choose to apply for one slice or both slices. In case, a bidder chooses to apply for both slices, bid fee will be Rs 3,000 only but bid security will be a combination of amount given above. Bid will be evaluated and awarded individually to each slice.
3. Interested eligible bidders find the bid document accessing government's digital procurement portal : www.bolpatra.gov.np/egg. Bidders should submit bids only through this portal as specified in the Public Procurement Act of Nepal.
4. Interested bidder must include the scanned copy of voucher of bid fee as mentioned above in given account:

Bids shall be opened in presence of bidder's representatives who choose to attend on 14:00 hours on 7 Baisakh 2077 (April 19, 2020) at the office of National Tuberculosis Control Centre, Thimi, Bhaktapur, Nepal. Bids remains valid for 90 days counting from the date of bid opening and

must be accompanied by bid security amounting to minimum of as mentioned above for each slice. The bid security must be valid for 30 days beyond the bid validity period.

5. Pre-bid meeting will be held at 13:00 hours on 20 Chaita 2076 (2nd April 2020) at NTCC. Interested bidders are encouraged to attend the meeting.
6. If the bidder intends to submit bid security in cash, please deposit in bank as given below and enclose the deposit voucher in bid document pack.
