

**Invitation for Bids for

4. A. Interested bidder shall submit bid electronically through PPMO's e-GP system accessing www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document in the following Rajaswa (revenue) account.

5. Electronic bids through PPMO's e-GP system www.bolpatra.gov.np/egp should be submitted before **12:00 hours** on **17 Poush 2077**. Bids received after this deadline will be rejected.
6. The bids shall be opened in the presence of Bidders' representatives who choose to attend at 13:00 o'clock, on **17 poush 2077** at the office of NTCC, Thimi, Bhaktapur, Nepal.
7. Bids must be valid for a period of 90 from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **140,000.00** (if bid cover all three slices, otherwise bid security should cover bidded slice only), which shall be valid for 120 days.
8. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. In the case of discrepancies or error in bid documents, bid notice or any other document, the NTCC reserves the right to amend and correct the bid at any time.
10. NTCC reserves the right to cancel the bidding process at any time if required.
