National Tuberculosis Control Centre, Nepal invites electronic bids from eligible bidders for the procurement of Medicines of Tuberculosis (for adults) under International competitive bidding procedures specified in Public Procurement Act and Regulations.

1. The bidder may submit the bid for single or more slices as mentioned below and offer discounts/ cross discounts. Bidders shall quote for the complete quantity of each slice. Evaluation shall be conducted of each slice and the contract award shall be made for each slice.

2. Medicine(s) offered by a bidder must be WHO pre-qualified.

4. Bid is to be uploaded and submitted electronically through PPMO's e-GP system www.bolpatra.gov.np/egp by 12:00 Noon of 4th February, 2022.
5. Electronic bids should deposit the cost of bidding **document** and Bid security as specified below. And also the evidence of bank receipt of bid fee and bid security should be enclosed in bid document.

6. Pre-bid meeting shall be held at National Tuberculosis Control Centre (NTCC), Thimi, Bhaktapur, Nepal at 11:00 AM on 5th January, 2022.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours, on 4th February, 2022 at the office of NTCC, Thimi, Bhaktapur, Nepal.
8. Bid must be valid for 120 days after the date of bid opening and must be accompanied by Bid Security not less than the amounts mentioned above for each slice or the equivalent in a freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Commercial Bank/ Financial Institution in Nepal. The Bid Security must be valid for thirty (30) days beyond the bid validity period.
9. If the bid opening day falls on a government holiday, then the bid opening shall be rescheduled for next working day and at the same time.
10. In the case of discrepancies or error in bid documents, bid notice or any other document, the NTCC reserves the right to amend and correct the bid at any time.
11. NTCC reserves the right to cancel the bidding process at any time even without disclosing the reason.
