5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours, 23 Chait 2076 at the office of NTCC. Bids must be valid for a period of 45 from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 81,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e. 7 Asar 2077).
